- I. CONVENE 5:30 PM Craig McIntosh, Jonna Buer, Sara Tabrizi, Betty Brody, Robert Gregory,

- II. APPROVAL OF MINUTES A motion was made and second to approve the minutes as presented (S. Tabrizi (M); C. McIntosh (S); Unanimous).

III. FINANCIALS REVIEW

- a. August Financial Report We are on track for the 2023 budget.
- b. Budget Review The assessment will be \$195/mo. beginning in 2024.
- c. CD Rates Update The Board has asked that the CDs be automatically moved to a prior rate instrument upon maturation in November. Management to follow up with accounting to ensure this occurs.

- a. Silvercreek recommends community lighting, signages, and neighborhood watch committee.
- b. Camera Expenditures are extremely high and usually not worth the investment.
